Female Pedophiles

This article may cause the reader to question the disturbing behavior of mothers, child care workers, teachers, mentors, athletes, physicians, religious leaders and other females in nurturing positions. This is an article about **Female Pedophilia** - one of the most undiscussed taboos in society that needs to be addressed.

The complexity of female pedophilia is overwhelming and society becomes silent when this subject is presented for discussion. Cultural stereotype and society's denial allows sexual encounters to occur between females and underage children. Society began to recognize that not only men had predatory activity, but females possessed the same capability. In the case of [Mary Kay Letourneau](#), her victim and society appears to have portrayed *her* as the victim, thus the viciousness of a nurturing female perpetrating a sexual crime on a child becomes difficult to comprehend.

Forensic Psychiatrist [Dr. Richard Hall](#) defines female pedophilia as a "*clinical diagnosis described by a psychiatrist/psychologist*" and not to be confused with the FBI's definition of forcible sexual offenses against one who is incapable of giving consent. The Diagnostic and Statistical Manual of Mental Disorders, Fourth Edition states that "*a pedophile is a person who fantasizes, is sexually aroused or experiences sexual urges toward prepubescent children for at least a 6 month period*". Unless a pedophile is apprehended for a crime against a child, the pedophilia activity will go undetected by the public. [Criteria for a pedophile](#) is "*a minimum of 16 years old and at least 5 years older than the victim and has a basic sexual attraction to children whether intoxicated or sober*".

Although exposing children to environments occupied by pedophiles, female pedophiles are not easily detected because they are meshed within society's normal activities such as teaching/mentoring, coaching, taking care of children in the role of child care/health care or religious care . . . and yes, even between mother and child. This is a nefarious crime and is often done under the pretense of normal daily activities. One wonders how the most revered female of the species (mothers) can risk her life to incubate a baby for nine months and then betray the innocence of that child.

In 1999 Dr. Christine Hatchard founder of [Making Daughters Safe Again](#) organization reveals perplexing data. Dr. Hatchard (Doctor of Clinical Psychology with a masters in counseling psychology and a faculty member at Monmouth University) has devoted eleven years to researching mothers who molest their daughters. Pedophilia statistics are derived from [studies involving incarcerated people](#) and legalized sexual treatment, thus a strong potential for bias reporting.

The Model Penal Code is "science based criminal law reform" using the [Kinsey report](#) funded by the Rockefeller Foundation, Dr. Alfred C. Kinsey began his nonprofit research project regarding sexuality in 1938 he took over coordination of [the new marriage course](#) at Indiana University, and soon after began gathering case histories of sexual behavior, Kinsey and his staff collected over 18,000 interviews, and published [Sexual Behavior in the Human Male](#) in 1948 and [Sexual Behavior in the Human Female](#) in 1953 which is now referred to as the Kinsey reports.

Media forensic expert Dr. Judith Reisman, (consultant to four U.S. Dept. of Justice Administrations) is a key opponent to the research of Dr. Alfred C. Kinsey and has documented her opposition citing [The Kinsey report](#) included 6000 females in experiments and challenged the beliefs of conventional sexuality, thus changing the public's perception.

An article by Robert H. Knight titled [How Alfred C. Kinsey's Sex Studies Have Harmed Women and Children](#) discuss the impact on our culture and laws. The ALEC Report (American Legislative Exchange Council) composed of 2400 state legislators across the nation (quote) "reveals compelling evidence of illegal and criminal acts masquerading as science taken from Kinsey's confessions in his own "Reports" (1948-1953). [The ALEC Report](#) contains shocking and surprising details regarding the Kinsey studies Wardell Pomeroy co-author of the Kinsey Report stated that Kinsey was actively engaged in: "the revision of sex laws" in New York, New Jersey, Delaware, Illinois, Wyoming and Oregon. The report notes that Kinsey was an activist to change laws Dr. Charles Rice of Notre Dame and Professor of Constitutional Law states that Dr. Kinsey's research was: (quote) ". . . contrived, ideologically driven and misleading. Any judge, legislator or other public official who gives credence to that research is guilty of malpractice and dereliction of duty" In 1987 the [Journal of Pedophilia](#) published by the Stichting Paidika Foundation had an objective... to promote the *normalization of pedophilia*.

This causes one to question if a criminal act is [publicly desensitized](#), would the behavior become more acceptable by society? Pedophilia has not always been a covert activity. A website advocating activity between women and pubescent girls was removed from the internet in 2002. Butterfly Kisses was considered to be the auxiliary to the active organization [NAMBLA](#) (North American Man Boy Love Association).

Dr. Richard C. W. Hall, MD, PA stated in the [Mayo Clinic journal](#) that between 47% - 100% of researched females who sexually violated children had also been sexually abused.

Penn State which receives taxpayers' funding [held an event in 2001](#) under the premise of freedom of speech with guest speaker sex pedophile- sadomasochist advocate Pat Califia aka Patrick Califia-Ross a bisexual transgender.

Where is the freedom of speech boundaries when advocating criminal activity such as pedophilia sex? It's not a choice. It's a crime!
