Child Prostitution

Exposing Mainstream Pedophilia

They came to be known as [The Children of Table 34](#). 317 infants and boys were used as research in an experiment in a sound-proof lab by Dr. Alfred C. Kinsey and his team at the Kinsey Institute in Indiana.

Dr. Alfred C. Kinsey promoted the philosophy that children are sexual from birth and they have a right to sexuality at any age. Kinsey's sexual research data was based on the activity of males which included sex offenders and prison inmates and recorded the stimulation of young children who "wept," "fought," "fainted" and had "convulsions." Many questions such as 'how were these children obtained for the experiments and did the parents know the basics and consent' are still unanswered. As with any research, follow-up is required, however, Kinsey did not follow-up on the Children of Table 34, thus an active search is still in progress for The Children of Table 34.

Decades later [Dr. Judith Reisman](#) Principal Investigator and author of the U.S. Department of Justice, Juvenile Justice Study, *Images of Children, Crime and Violence in Playboy, Penthouse and Hustler* (1989), *Kinsey, Sex and Fraud* documented [fraudulent data and illegal experiments](#) by Kinsey and his closest friends Wardell Pomeroy and Paul Gebhard.

Pomeroy labeled it Kinsey's Grand Scheme and [launched the sexual revolution with Hugh Hefner](#) Kinsey's greatest disciple of promotion. Per Pomeroy's "*Girls and Sex*", 1969, which was a sex education book used globally, Wardell Pomeroy stated that the medical reason for incest taboo was that "*the children of an incestuous union will be likely to inherit the outstanding good characteristics of both (parents)*".

According to the December 1977 Penthouse issue, Philip Nobile 'Penthouse' forum editorial director, promoted ending the incest taboo and based his sources on Gebhard's study. In essence, Kinsey, Pomeroy and Gebhard made incest harmless! Notice there were no female researchers and physicians recommending incest. Once again mainstream magazines were condoning the victimization of children.

Per Dr. Reisman's report: [History & Science: Erototoxic Images Drive Sex Trafficking Demand](#) Pornography was defined as sexually explicit media and functioned as **erototoxins** which she considered "*the toxic side of eros*". Pornography objectified a person as an object to simply be used

as an orifice recipient. She further stated that ["Erototoxins sexualize children and increase the demand for trafficked women and children"](#).

The December 1953 issue of Playboy depicted wives as gold diggers, portrayed Haitian and American women as prostitutes and a French prostitute *awaiting stripping by affluent men*. These stereotypes appear to thrive today.

Dr. Reisman's 1985 Dept. of Justice Report *Images of Children, Crime & Violence in Playboy, Penthouse and Hustler* (12/53-12/85) published a chart depicting the photographs, cartoons and illustrations of children used in Playboy, Penthouse and Hustler magazines. [Selected Findings Chart](#).

Disney star [Brittany Spears](#) and her backup dancers gyrated their way across the 1998 video screen wearing versions of the Catholic school uniform. Erotic magazines have adopted this uniform as a common sexual fetish costume in western culture equal to the [sailor fuku in the Japanese culture](#).

The song "One More Time" became famous and was promoted with a picture of Brittany with her hands in a prayer position. The lyrics: "give me a sign . . . hit me baby one more time" was a dichotomy. Was the subliminal violence connotation directed at the sadists-masochists market? It was interesting to note that the follow-up song Born to Make You Happy was all about catering to someone else's needs.

Have you noticed how many Disney Kids became sexually exploited superstars? Is this an erotic toxin for the public to relate to a Disney wholesome image only to be exploited sexually and/or financially and at the mercy of greedy handlers who have now objectified the entertainer/actresses/actors? How many lawsuits in Florida were initiated, but were settled out of court so the seamy details would not be known to the public?

Internationally acclaimed film "Little Miss Sunshine" and winner of two Academy Awards gave the pedophiles a treat when the seven year old little girl danced a burlesque routine that had been secretly choreographed by her grandpa Edwin. This was grandpa's solution to equalize the beauty pageant competition with sexualized pre-teen competitors. Who can forget the tragedy of a little 6 year old beauty pageant winner [Jon Benet Ramsey](#)? Why must children be subjected to aesthetic competition at 6 years old?

The Catholic Church has had its problems with the [shuffling of predators](#). It appears it's not just synonymous with the Catholic faith, however, since numerous religious organizations have their dirty little secrets, also. Victims of pedophilia are international. On June 25, 1987, Paul Lewis shook the UNICEF organization with his article in the [New York Times](#). The Belgian branch of UNICEF arrested Jos Verbeek, 63 years old who was the Director of the Belgian UNICEF Committee and charged him with "inciting minors to debauchery."

Those same offices provided a location for pornographic photos of children most notably of North African origin. Police seized 1000 photos and a mailing list of 400 names representing 15 European countries on

a UNICEF computer. Another UNICEF employee whose duty was to organize computer classes for the children, Michel Felu, was arrested, also.

The [Infowars Ireland](#) website referred to Japan as being the "child porn superpower" and the potential of sex offenders being blackmailed within the British government. They went so far as to publish a list of the [child sex offenders inside the British government](#).

Bryan Bender of The Boston Globe, July 23, 2010 discusses by video the U.S.A. [Pentagon workers](#) with high security clearances and their tie to child pornography.

Publishing houses recognize the pedophile market and make books available. Due to public pressure, [Amazon.com pulled an online book for pedophiles](#) although [the author is confident his book will be returned](#). Why didn't the public ask Amazon to pull all books advocating pedophilia? Yes, there are seven additional books remaining.

The Centre for Addiction and Mental Health, Nov. 28, 2007, Toronto states "[Pedophilia might be the result of faulty connections in the brain, according to new research](#)." Is it all about irregular brain connections? Because politicians are being pressured by parents and the public to protect children from predators, the environment is on the verge of change. Although pedophilia is often in the news headlines, researchers go out of their way to avoid this subject.
