Child Prostitution

In 1999 Sweden decriminalized the selling of sex and *criminalized the purchasing of sex*. This was Sweden's approach to child trafficking and prostitution, thus decreasing the number of pimps by 80%. The Swedish government regards prostitution as a form of exploitation and violence against women and children. Presently, Sweden is considered a global rescue leader and provides education regarding prostitution to the public and assists prostitutes who want to leave the profession. Who will become the brave politician to initiate a law change in America that could protect exploited women and children who are victims?

There are many enablers to the child prostitution industry and it's their greed that allows the victimization of children to continue. Although Craigslist was originally a grassroots community service in 1995 that specialized in posting art and technology activities, by February 2009 the FBI confirmed more than 2,800 prostitution ads for sex with children, thus justifying a major sting operation. 571 arrests were made and 48 prostituted teens as young as 13 years old were located. Why did it take pressure from 18 Attorney General Offices within the USA and activist groups to get Craigslist to withdraw their escort and erotic service ads? It appears that \$3.7 million in monthly fees generated by erotic service ads to Craigslist was valuable revenue and not easily relinquished. Eventually, Craigslist agreed to discontinue those services in the USA **only** and continues to permit ads outside of the states. This has now allowed for backpage.com (which is associated with Village Voice Media an entertainment industry paper) to become the leader in erotic service ads.

The multi-billion dollar child sex tourism industry is commercialized child sex abuse which leaves devastating psychological, emotional and physical consequences of unwanted pregnancies, drug addiction, social ostracism and death. Poverty, war, corruption, travel ease and lack of enforcement of laws are key factors contributing to the horrendous crimes against children. The international sex tourism is comprised of 80% Costa Rica, 38% Cambodia and 25% Americans according to the Youth Advocate Program International in Washington, D.C. The Central Bureau of Intelligence states there are approximately 1.2 million children in India involved, also. This kind of crime is not confined to the male gender.

Why is society so reluctant to label a female who sexually violates an underage male or female child a "pedophile"? Because female pedophilia is still in the closet as an un-discussed taboo and unless the female pedophile is caught violating a child, they will go undetected until a crime has been reported. This

is very disturbing given the fact that female pedophiles are mothers, nannies, childcare workers, girlfriends and teachers who are in positions of trust.

Pedophilia has no borders. It is a crime regardless of the gender of the perpetrator. What are the criteria for a pedophile? The predator must be a minimum of 16 years old and at least 5 years older than the victim and have a basic sexual attraction to children whether sober or intoxicated. Forensic Psychiatrist Dr. Richard Hall stated in the Mayo Clinic journal that somewhere between 47%-100% of female pedophiles had also been sexually abused.

Does a crime become more tolerable by the public when drugs or alcohol are involved? Didn't the perpetrator make the initial choice to use alcohol or drugs, thus leading to the crime? Try and explain to an innocent child that their victimization is lessened because alcohol and drugs are to blame.

Although the Model Penal Code is Dr. Alfred Kinsey's *science based criminal law reform*, based on the Kinsey reports *Sexual Behavior in the Human Male*, 1948 and *Sexual Behavior in the Human Female* in 1953, we now realize those experiments on *The Children of Table 34 (317 infants and boys who endured activity which included sexually stimulating infants as young as five months to children 14 years old within a soundproof lab)* were done using prisoners and Kinsey's team of researchers. In fact, these experiments were illegal and fraudulent according to Dr. Judith Reisman. *Principal investigator and author of the U.S. Department of Justice, *Juvenile Justice Study, Images of Children, Crime and Violence in Playboy, Penthouse and Hustler* (1989).

Child prostitution and human trafficking have become a daily occurrence that needs to be stopped - now! Why hasn't society become enraged with the 'new slave trade'?

INTERPOL, FBI, CBI, and ICE have barely dented the child prostitution industry because it replenishes continuously at a very fast rate.

The Protect Act of 2003 was initiated to prevent child abuse. This law permits criminal background checks for volunteer organizations, authorizes the wiretapping and monitoring of other forms of communications related to child abuse or kidnapping and eliminates the statutes of limitations for child abductors or abusers. Unless a law is enforced, it becomes meaningless.

Since our March series **Youth Without a Future - Juvenile Life Without Parole (JLWOP)**, the Florida Supreme Court [ruled in May 2010](#) that *Juvenile Life without Parole in non-homicide cases is unconstitutional*.

The **Observer Child Prostitution Series, Part 3 Promoters of Pedophilia - Prostitution** exposed Craigslist as having a \$3.7 million monthly revenue generated by erotic service ads. In February 2009, 2,800 prostitution ads for sex with children were posted on Craigslist. Although it took pressure from 18 Attorney General Offices and activist groups around the country to pressure Craigslist to withdraw their erotic service ads in the USA, they continued to accept ads from other countries.

According to the AIM Group, 150,520 erotic sex service ads were posted within a thirty day period within Canada's major cities of Victoria, Vancouver, Toronto and Montreal. British Columbia's child sex trade occurs in karaoke bars, massage parlors and locations known as trick pads. As of December 18, 2010, [Craigslist will no longer display the controversial sex ads, price and photos on Canadian sites](#). **Kudos to Canada!**

On November 22, 2010, 'The Observer' **Child Prostitution Series, Part 4** Exposing Mainstream Pedophilia alerted their readers that:

Publishing houses recognize the pedophile market and make books available. Due to public pressure, [Amazon.com pulled an online book for pedophiles](#) although [the author is confident his book will be returned](#). Why didn't the public ask Amazon to pull all books advocating pedophilia? Yes, there are seven additional books remaining. Dec. 20, 2010, My Fox Orlando reported the ["author of pedophilia how-to-book arrested"](#) in Colorado on a Florida Warrant . . . **Kudos to Polk County , Florida, Sheriff Grady Judd and his detectives!**
